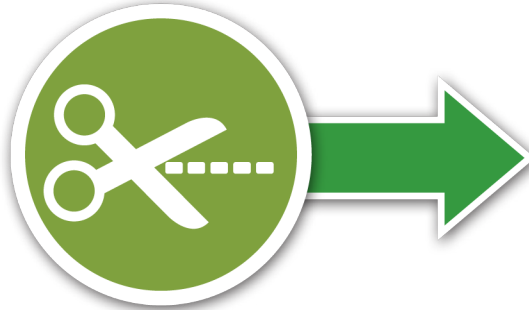


**Print It****Cut It****Fit It**
